| | | 1. Property must comply with and meet all current NYS Uniform Building Codes |
| | | 2. There shall be one working smoke detector in each sleeping room and one additional smoke detector on each floor. Carbon monoxide detectors shall be installed as required by the NYS Uniform Fire Prevention and Building Code. |
| | | 3. Evacuation procedures must be posted in each sleeping room to be followed in the event of a fire or smoke condition or upon activation of a fire or smoke detecting or other alarm device. |
| | | 4. There shall be an ABC fire extinguisher on each floor and in the kitchen. Fire extinguishers shall be inspected prior to a renter occupying the property and not less than monthly by the permit holder(s) to ensure each contains a full charge. A record of the date inspected initialed by the permit holder shall be maintained and made available to the Code Enforcement Officer if requested. |
| | | 5. The house number shall be located both at the road and on the dwelling unit so that the house number is clearly visible from both the road and the driveway. |
| | | 6. Copy of NY State insurance policy showing property/liability coverage as a short term rental. |
| | | 7. Electrical systems shall be in good operating condition, labeled, unobstructed and shall be visible for the Code enforcement Officer if requested. Any defects found shall be corrected prior to permit issuance. |
| | | 8. All fireplaces shall comply with all applicable laws and regulations. |

| | | 9. The property must have a minimum of one (1) off-road parking space for every bedroom shown on the floor plan included with the application. Parking on the NYS, county or town right of way will not constitute a parking space. |

| | | C. State that the Short-Term Rental is in a residential area |
